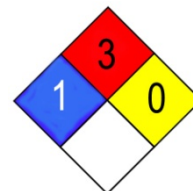

### 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

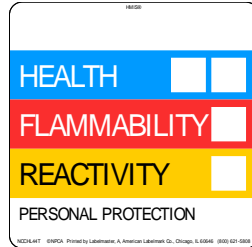

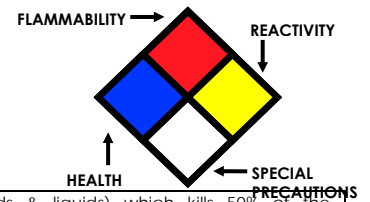
