



JimmyGel Fill Maintenance

Aim of the treatment: Proper maintenance of a **JimmyGel** manicure treatment.

Treatment Time: 30-45 minutes

Preparation: Prepare work area with an **LEpro Big Wipe** and all essential tools and products required for service to be performed. Have client make color choice as you prepare the nails for the **JimmyGel** fill.

PRODUCTS REQUIRED

LE Zippy E-File
Speedy and Preppie Z-Bits
Favorite LE Nail File
LEpro Cleanser
LEpro Cleansing Wipes
LE Duster Brush
LEpro Cuticle Pusher
JimmyGel
LE Color/Glitter/Buttercream or P+
LE Top Coat of choice
LEpro Cuticle Oil

Step-By-Step Procedure

- **STEP 1:** Follow **Light Elegance Fill Prep Protocol**, to prepare the nails for nail services.
- **STEP 2:** Using the **LE Zippy E-File** and **Z-Bits** or your favorite **LEpro** nail file, shorten nails (if desired), remove previous decoration gels, rebalance stress area and apex of the nails, filing the product to be flush with the nail plate.
- **STEP 3:** Remove dust from the nails with the **LE Duster Brush**. Using **LEpro Cleanser**, cleanse the nails and inspect the nails and the product to be sure it is all in good condition.
- **STEP 4**: Apply Tack to regrowth area of the nails, cure for 30 seconds in the **LEDdot** lamp.
- **STEP 5:** Apply a Slip Layer of **JimmyGel** to the regrowth area of nails on one hand, pulling a very thin coat of **JimmyGel** over the existing product. ***Do not Cure yet***
- **Step 6: Before Curing,** add a droplet of **JimmyGel** right at the base of the existing product on each nail, to allow the Apex of the nail to transition smoothly to the nail plate. **JimmyGel** will self-level to a smooth application. Cure for 1 minute in **LEDdot** lamp.
- **STEP 7:** Repeat Step 5 and Step 6 on nails of second hand.

<u>If no color application is desired</u>- Applying a Top Coat is optional. **JimmyGel** can be applied as a clear overlay to add some strength to the natural nail and will cure to a nice shine. Move on to Step 13.





STEP 8: (**Optional**) If any adjustments are needed to smooth the application, cleanse the nail with **LEpro Cleanser** and **a LEpro Cleansing Wipe**. Filing to refine the nails can be done with a **Lexy File**, **Perfect File** or buffing with the **LE Foamie**, to completely smooth the nail surface.

STEP 9: If filing or buffing was done, use the **LE Duster brush** to remove dust from the nails and using **LEpro Cleanser** and a **LEpro Cleansing Wipe**, thoroughly clean each nail plate, removing all dust.

STEP 10: Apply any P+ Color or Glitter, LE ButterCream or Color or Glitter gel product of the client's choice, cure in **LEDdot** lamp for 30 seconds.

STEP 11: Apply a second coat of chosen decoration gel, cure in **LEDdot** lamp for 30 seconds.

STEP 12: Apply a thin application of desired Top Coat* and cure for 1 minute in the LEDdot lamp. *If P+ color or glitter was used, finish the nails using P+ Top Coat.

STEP 13: Using **LEpro Cleanser** and a **Lint Free Wipe**, thoroughly clean the entire nail plate cuticle to free edge, removing the inhibition layer.

STEP 14: Using **LE File** of choice, gently file along bottom side of free edges, to insure a smooth finish around the nails.

STEP 15: Massage 1 drop of **LEpro Cuticle Oil** into each cuticle.

(Add-on option) Apply a nickel size amount of **Q&Lu Bamboo Lotion**. Massage hands and arms. Massage can be extended by adding 1 pump of **Q&Lu Spa Oil** to the **Q&Lu Bamboo Lotion**.

Recommended Retail Products

LEPRO CUTICLE OIL- keeps nails and cuticles moisturized

Q&LU BAMBOO LOTION- hydrates and moisturizes skin.

Q&LU SPA OIL- great after bath or shower to soften skin.

TIPS:

To ensure proper product adhesion, the nail plate must be cleansed prior to nail prep.

If additional structure and strength is desired, Step 5 and 6, can be repeated.

If finish filing is not required, Color, Glitter and P+ gels can all be applied directly over the inhibition layer of JimmyGel.
